




Coastal Conservancy Mission: To act with others to preserve, protect and restore the resources of the California coast, ocean and San Francisco Bay Area




Coastal Conservancy

The Coastal Conservancy was created with a broad mandate and a specific jurisdiction. This structure enables the Conservancy to develop and implement multi-benefit projects tailored to specific regional need to achieve statewide goals.

The Coastal Conservancy's jurisdiction includes coastal draining watersheds, the entirety of the nine Bay Area counties, and the Santa Ana River Watershed. The jurisdiction covers about 30% of California's land area and approximately 75% of the population.



Draft Prop 1 Guidelines, Process

- Four solicitation periods each year
- Screening
- Scoring
- Grant Award
- Grant Agreement



Draft Grant Scoring & Evaluation

Priorities in Prop 1

- * advances purposes of Prop 1
- * leverage funding
- * produce the greatest public benefit
- * best available science informs decisions
- * use new or innovative technology or practices.

Bonus Points:

- * Greater than 100% matching funds
- * Benefits Disadvantaged Community

Projects reviewed by professionals in relevant fields.



Prop 1 Guidelines, revisions

Disadvantaged Community defined Water Code 79505.5 (a) "a community with an annual median household income that is less than 80 percent of the statewide annual median household income."

Conservation Corps:

Restoration and ecosystem protection projects **shall** use the services of the California Conservation Corps or a certified local conservation corps when feasible. (79734)

Federal agencies are not eligible grantees. "Public Agency" defined as state agency or department, special district, joint powers authority, city, county, city and county, or other political subdivision of the state.
