
PROGRAM HIGHLIGHTS

Estuary Youth Council

SFEP gathered three community-based organizations Nuestra Casa, Mycelium Youth Network, and Restore the Delta to kick off the Estuary Youth Council. These three organizations will work with SFEP to co-develop and co-implement the program, and have begun meeting regularly to develop the structure, programming, and goals of the first Estuary Youth Council. We'd like to thank our funders — anonymous donors from the Honey Hive Fund, and Friends of the Estuary, for their support of this effort.



Wetlands Regional Monitoring Program



The WRMP <u>Spring 2023 Newsletter</u> was released in March. This newsletter edition highlights key accomplishments during the first quarter of 2023, including identification of priority monitoring sites, new staff, workgroup progress, and upcoming work.

Estuary Blueprint

The Blueprint Steering Committee met on April 6 to continue its work to advance implementation of the Estuary Blueprint. Committee members discussed the reporting tools developed to communicate Blueprint progress and explored options for more nuanced storytelling of Blueprint work. The Committee continued a deep dive into the list of Estuary Partnership (Coordinator) tasks identified as needing the most support, with a focus on the Creeks action (Action 14) and the use of EcoAtlas as a tracking tool for riparian restoration projects. San Francisco Bay Joint Venture staff led a robust discussion of EcoAtlas, indicating the potential for a larger regional conversation in the future.



In addition, the Estuary Blueprint Social Science Advisory Team members have been selected and have been announced on social media and on the Estuary Partnership's website. The Social Science Advisory Team will be reviewing the 2022 Estuary Blueprint for integration of social science in the plan and will be delivering recommendations to the IC in the future. A kickoff meeting is being planned for the summer.

Transforming Shorelines Collaborative on Nature-based Adaptation and Mitigation

The fifth meeting of the Transforming Shorelines Collaborative centered on: (a) understanding the suite of mitigation requirements associated with nature-based shorelines adaptation; (b) learning about creative strategies for funding mitigation banking statewide; and (c) brainstorming opportunities and challenges for the SF Bay. The first three presentations covered the regulatory mitigation processes applicable for nature-based solutions (NbS), with specific attention paid to CWA Section 404 Permits. The second two presentations covered a suite of mitigation options potentially applicable for NbS, including the in-lieu fee program and mitigation credit agreement program proposed in the SF Bay and Delta regions. Breakout groups largely focused on the challenges associated with mitigation, ultimately concluding that increased communication and collaboration across agencies and organizations will be necessary to promote the adoption of NbS.

FUNDING OPPORTUNITIES

EPA's SF Bay Water Quality Improvement Fund - BIL Request for Applications


EPA is soliciting applications under the BIL funded <u>SFBWQIF Request for Applications</u> (<u>RFA</u>) to fund projects that have measurable positive impacts in underserved communities of the San Francisco Bay Area, including improving the land and water of communities with environmental justice concerns and addressing climate change. \$5 million is available in this round with applications due June 29th.

Also note that the base Water Quality Improvement Fund RFA is also coming soon with close to \$30 million expected to be available.

Estuary News Magazine

The <u>last issue</u> of Estuary News Magazine was released in March. In this special Almanac of Restoration, Estuary News celebrates 30 years of restoration in all its forms and samples projects of every kind. Starting high up in the watersheds with rivers, lakes and creeks, moving into the Delta, and then exploring San Francisco Bay. The issue looks for results: did the birds and fish come back?
