#### 1. Welcome/Intros

Tom Mumley called the meeting to order, introduced the attendees, and reviewed the agenda

# 2. Approve 3/15/23 Meeting Summary (ACTION)

Motion to Approve 3/15/23 meeting summary by Warner Chabot, seconded by Barbara Salzman. Motion carried.

# 3. Director's Report

Caitlin Sweeney highlighted several items in the Director's Report:

- Last issue of Estuary News was released in March. Encouraged to message Caitlin for a hard copy.
- Breaking news that was not included in the Director's Report. Officially announced that
  we have been issued \$4.3 M from US EPA Region 9 for a project called Breaking Ground.
  Includes construction of the Palo Alto Horizonal Levee project, Community based
  monitoring and education, and advancing the design of two nature-based shoreline
  projects.
- Transforming Shorelines Collaborative is seeking input from partners on ideas for future meetings
- Sandra Scoggin is leaving the SF Bay Joint Venture, and we wish her the best

# 4. Estuary Blueprint Implementation: Task 3-6

Sea Level Rise Funding and Investment Framework

Caitlin Sweeney introduced the Blueprint Task, informed the Committee that the Task has been completed, and introduced Rachel Hartofelis, of ABAG/MTC and Dana Brechwald, of BCDC. Rachel and Dana presented on the Sea Level Rise Funding and Investment Framework.

Highlights include the estimated cost of sea level rise adaptation at \$110 billion through 2050 but a revenue estimate of only \$5.5 billion. Measures to increase revenue were reviewed, including a parcel tax, an ad-valorem tax, and GO bonds, with an ad-valorem tax and GO bonds placing a lower burden on socially vulnerable areas.

A question and answer period followed. Final report will be available in early June.

# 5. Estuary Blueprint Implementation: Task 3-5

Priority Conservation Area Framework Refresh Project

Caitlin introduced the Blueprint Task and Ben Botkin, of SFEP. Ben presented on the current status of the Priority Conservation Area Program Refresh and the PCA Grant Program. One highlight is the addition of climate adaptation and a prioritization category. The refresh process is approximately 50% complete and is expected to be completed by Winter 2024.

A question and answer period followed.

### 6. Estuary Blueprint Implementation: Actions 1-4

Bipartisan Infrastructure Law (BIL) Program: Years 1-2 Workplan Updates and Equity Strategy

Caitlin introduced the Bipartisan Infrastructure Law and James Muller, of SFEP. James provided a presentation on the Bipartisan Infrastructure Law Year 2 Workplan and Equity Strategy.

Highlights included SFEP's approach to the BIL, a review of the Year 1 Workplan, and Year 2 projects, including: the Novato Creek OLU, the Wildcat Creek OLU and Watershed, the Estuary Youth Council, SFEP Equity Team, Internal training and systems review, Grant writing assistance for CBO's and Tribes, and outreach and communications. James also reviewed the Equity Strategy being used for the BIL program.

A question and answer period followed.

#### 7. Final FY 24 Workplan and Budget (ACTION)

Caitlin Sweeney reviewed that the draft FY 24 Workplan and Budget covered at the March meeting was not updated. Caitlin requested approval of the final FY 24 Workplan and Budget. Becky Smyth motioned to approve and Arthur Feinstein seconded. The motion carried.
