- SFEP is pleased to have received \$1M from the State Water Resources Control Board to build an online platform for the State of the Estuary Report.
- SFEP will be using the 2<sup>nd</sup> year of Bipartisan Infrastructure Law (BIL) funding from the EPA to support work in North Richmond, the Novato Creek Operational Landscape Unit (OLU), and the Estuary Youth Council.

## 4. Delta Residents Survey

Tom Mumley introduced the Delta Residents Survey and Jessica Rudnick, California Sea Grant Extension Specialist/Delta Stewardship Council. Jessica presented the methodology and results of this large-scale household survey that aims to identify the links between the Delta and wellbeing. A question-and-answer period followed. Bay-Delta Water Quality Control Plan Update

Nicole provided an overview of the Draft Staff Report on the Bay-Delta Water Quality Control Plan Update and the public comment process. Caitlin introduced that the Estuary Partnership is seeking opinions on a potential comment letter for the Draft Staff Report. A question-and-answer period followed that led into a discussion on which partners would need to abstain from signing as well as the consensus process. As no consensus was reached, the IC will not be drafting a comment letter.

Regulatory Pathway Priorities for NbS
