COMPLETED PROJECTS

Pacheco Marsh

The 122-acre Pacheco Marsh officially opened to the public on May 3, 2025. A ribbon cutting event was held at the site the day before for all the project partners, including SFEP staff. The public access portion of the project, including a kayak launch and 2.4 miles of trail, was led by the John Muir Land Trust and its many partners. The Contra Costa Conty Flood Control and Water Conservation District and their partners led the earlier portion of the larger Lower Walnut Creek and Pacheco Marsh Restoration Project which restored tidal influence to Pacheco Marsh with a levee breach in October 2021 and established over 30,000 plants.

The larger was funded by many different sources including several funding sources managed by SFEP staff including the San Francisco Bay Restoration Authority, the Priority Conservation Area Grant Program, and the Integrated Regional Water Management Program.

COMMUNICATIONS

First Mile Horizontal Levee project to appear in an upcoming OpenRoad Episode

The Estuary Partnership joined a multi-location filming session with project partners to shoot footage for an upcoming OpenRoad episode for NBC featuring our First Mile Horizontal Levee Project. The project of focus reimagines a mile of shoreline at the Hayward-San Lorenzo border, increasing public access, enhancing habitat, and providing space for native species to retreat as sea levels rise. The episode is planned to air this summer.

Estuary Partnership participates in SF Climate Week

In April, the Estuary Partnership participated in one of the Bay Area's most high-profile climate events: SF Climate Week. We co-hosted this series with Bay Area Regional Collaborative in partnership with Bay Area Air District, KneeDeep Times Magazine, and Bay Conservation & Development Commission. Nearly 300 people joined our 5-part series on 'Who is Doing What About Climate Change? The Low Down on Bay Area Innovations' series along with our mixer. This event was part of nearly 300+

independently organized events across San Francisco that worked to connect leaders, scientists, practitioners, entrepreneurs, and students from every walk of life to have key conversations about the environment and climate.

PROGRAM MANAGEMENT

EPA 5-Year Program Evaluation Underway – August Site Visit Planned

As reported in my last Director's Report, every five years the Estuary Partnership undergoes a Program Evaluation (PE) by the USEPA to assess how the National Estuary Programs are making progress in achieving programmatic and environmental results through implementation of their Comprehensive Conservation and Management Plans (our Estuary Blueprint).

Our 2025 PE is currently underway, with the required package of required information submitted. The PE Team is evaluating the materials and will be attending the August IC meeting as well as touring various project sites.
